(ELEVENTH REVISION)

(FOR RENEWAL, SEE 49 CFR § 107.109)

1. GRANTEE: (See individual authorization letter)
2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transportation in commerce and temporary storage incident to that transportation of non-fissile or fissile exempt radioactive materials packages aboard highway vehicles when their combined transport indices exceed 50 or the separation distance criteria cannot be met. This special permit is subject to the implementation of a radiation protection program and other safety control measures. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
  - b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
  - c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 177.842(a) and 177.842(b).
5. BASIS: This special permit is based on the application of Associated Couriers, Incorporated dated July 6, 2004, submitted in accordance with § 107.109.
